## SOUTH CAROLINA FREEDOM OF INFORMATION ACT REQUEST

In accordance with the South Carolina Freedom of Information Act (FOIA), S.C. Code Ann.§ 30-4-10, et seq., Persons have the right to inspect, copy, or receive non-exempt Public Records. FOIA Requests for Public Records of Spartanburg County should be made through the following links

Requests may also be submitted by U.S. Mail sent to Spartanburg County, Attn: FOIA, P.O. Box 5666, Spartanburg, SC 29304, and by facsimile at 864-596-2232.

Spartanburg County charges a fee for the cost of the search, retrieval, and redaction of records based on the time necessary to complete such actions. The rate used to determine the charge due is the hourly rate of the lowest-paid employee qualified to perform the actions necessary to respond to the request. Spartanburg County also charges a uniform fee to copy documents provided pursuant to a request.

Spartanburg County will provide an initial response to a requestor within ten (10) business days of receipt of the request. However, if the records sought are more than twenty-four (24) months old, Spartanburg County will provide an initial response to the requestor within twenty (20) business days.
