Call to Order Regular Meeting - Chairman Steve Harper

Chairman Steve Harper called the County Council meeting to order at approximately 6:00 p.m.

Welcome and Recognition - Chairman Steve Harper

Chairman Steve Harper welcomed everyone to the meeting. He recognized Freddie Gault and Will Cantrell from Congressman Ralph Norman's office. He noted that if citizens needed constituent help, they would be available for assistance.

Pledge of Allegiance and Invocation - Council Member Terry Graham

Council Member Terry Graham led the Pledge of Allegiance to the American Flag and delivered the Invocation.

Approval of the Agenda

Charlene McGriff moved to approve the agenda. Seconded by Brian Carnes. Motion Passed 7-0.

Citizens Comments

The following citizens signed up for and spoke during Citizens Comments:

Special Presentations

Randy Duffy, Chair of the Accommodations Tax Advisory Committee, presented the Committee's recommendations for the distribution of funds from the State Accommodations Tax for fiscal year 2022-2023. He stated the Committee recommended funding the Carolinas Chili Championship at \$32,000; the Lancaster County Council of the Arts at \$20,760; the Lindsay Pettus Greenway at \$15,000; and the Friends of the Buford Massacre Battlefield at \$15,000, for a total of \$82,760. He stated that the County would have \$15,340 left to roll over into the next fiscal year grant cycle. Veronica Thompson stated the Lancaster County Accommodations Tax Advisory Committee met on June 1, 2023 and heard presentations from the grant applicants. She stated that Council just heard the presentation from Mr. Duffy. Jose Luis asked about the visibility of what the expectations were for the funding of these tax dollars. She answered that the guidelines were on the county website. She continued that the applicants know the information that would be required to receive the grant funds by looking at those guildelines. She stated the final reports give more details about the successes of the projects. Allison Hardin reviewed the County power point presentation regarding rezoning parcels at 8574 Charlotte Highway in order to align zoning and parcel boundaries to the existing road network. Jose Luis asked what would be done with the parcels. Ms. Hardin stated this would be an economic development project not yet named. Jose Luis stated that not having seen what the proposed development was, he would not be comfortable with additional development in Indian Land. Ms. Hardin stated it would be commercial development with a traffic analysis. Mr. Luis stated he believed such development would be problematic to the traffic problems in Indian Land.

Ordinance Title: An Ordinance To Amend The Lancaster County Code Related To The Residency Requirement For Certain Management Positions

Charlene McGriff moved to approve 1st Reading of Ordinance 2023-1851. Seconded by Billy Mosteller.

Dennis Marstall stated this ordinance would amend the County Code that required the County Administrator, Deputy County Administrator and the Economic Development Director to reside in Lancaster County. Council discussed the need for these positions to live in Lancaster County and noted that if there were any exceptions, they should be approved by Council. Charlene McGriff stated that she would not oppose giving candidates more time to move. Terry Graham stated the workforce has changed since 2016 and Steve Harper agreed and stated this could also limit the application pool. Allen Blackmon recommended promoting from within the County rather than promoting from outside the County. Steve Harper stated that this action may be overstepping the bounds of the Council-Administrator form of government. Ginny Merck-Dupont stated Council is responsible for writing personnel policies and parameters but, at the end of the day, the employees answer to the County Administrator.

Ordinance Title: An Ordinance To Amend The Official Zoning Map Of Lancaster County To Rezone Approximately 28.01 Acres (TM# 0010-00-029.00) Located At 8918 Charlotte Highway, Indian Land, From Light Industrial (LI) District To Regional Business (RB) District.

Allison Hardin reviewed the County power point presentation regarding rezoning property at 8918 Charlotte Highway from Light Industrial (LI) to Regional Business (RB) District.

Allison Hardin stated the draft traffic impact analysis (TIA) had been received and that staff was reviewing it. 2nd Reading of Ordinance 2023-1849 regarding Approval of the Fiscal Year 2023-2024 Budget

Ordinance Title: An Ordinance To Appropriate Funds And Approve A Detailed Budget For Lancaster County For The Fiscal Year Beginning July 1, 2023 And Ending June 30, 2024 (FY 2023-24); To Set Millage Rates For The Levy Of Ad Valorem Taxes; To Approve A Schedule Of Taxes, Fees And Charges For FY 2023-24; And To Provide For Matters Related Thereto.

Charlene McGriff moved to approve 2nd Reading of Ordinance 2023-1849. Seconded by Brian Carnes.

Chairman Harper stated that Council and staff had discussed some amendments that needed to be made. Kim Belk stated the budget would have a 4.1 mil increase to give Public Safety employees increases as discussed, as well as a 6.5% across the board increase for all employees. Kim stated property tax on a \$250,000 home plus two vehicles would be an increase of approximately \$26 on property taxes.

Allen Blackmon moved to approve a 10% increase for EMS. Seconded by Jose Luis.

Dennis Marstall stated he does not have the dollar amount that would be needed to increase EMS from 8% to 10%. Billy Mosteller stated he had an issue with only giving the Sheriff 10% increase when he requested 15% and then also to cut two deputies from his budget. Brian Carnes stated Council needed to fund four (4) additional detention center officers in preparation for the new detention center.

Brian Carnes moved to postpone 2nd reading. The motion died for lack of a second.

There were discussions on holding another budget meeting, changes to the budget, changes to the millage value, cuts to the budget, the budget process, planning a 5 year budget, and a career ladder for EMS.

Jose Luis stated there was still a motion and 2nd on the floor. Allen Blackmon called for the question. The motion to approve a 10% increase for EMS certified staff Passed 7-0.

Charlene McGriff moved to amend Ordinance 2023-1849 regarding approval of the Fiscal Year 2023-2024 Budget as follows:

- Create a competitive pay hierarchy for Fire Rescue and Emergency Management which brings the

minimum firefighter pay up to \$44,045;

- Include cost of living increases for the Solicitor and Public Defender at 6.5% to keep them equivalent to County employees;
- Add \$228,000 for Administration renovations as an additional project to be paid for with Fund Balance. Seconded by Brian Carnes. The amendment Passed 7-0.

Council and staff discussed adding sheriff deputies and detention center officers while keeping the millage increase in check.

Billy Mosteller moved to amend Ordinance 2023-1849 and add two deputies and four detention center officers in January 2024. Seconded by Charlene McGriff. The motion to amend Passed 7-0.

Dennis Marstall discussed the options for fire fees and reducing the Equivalent Residential Units (ERU). Council discussed commercial fees versus residential fees. Council asked if this item could be discussed Wednesday at the Committee of the Whole Meeting.

Allen Blackmon moved to amend Council's rules of order to extend the meeting past 10:30 p.m. Seconded by Jose Luis. The motion Passed 6-0; Absent: Carnes
