## AN ORDINANCE

**TO ADOPT THE REVISED LANCASTER COUNTY CAPITAL IMPROVEMENTS PLAN FISCAL YEAR 2021-2022 THROUGH 2030-2031 AS RECOMMENDED BY THE LANCASTER COUNTY PLANNING COMMISSION.**

Be it ordained by the Council of Lancaster County, South Carolina:

### **Section 1. Findings.**

- A. The Lancaster County Council adopted its *2021-2031 Capital Improvement Plan* ("CIP") in July 2021 (Ordinance # 2021-1726).
- B. The adopted CIP aligned to the Comprehensive Plan and supports the Infrastructure and Public Safety priorities of Lancaster County's Strategic Plan.
- C. The Lancaster County Planning Commission reviewed a list of new project requests, totaling \$22M, as part of the FY25 annual budget development process. The Planning Commission confirmed project alignment to the current Comprehensive Plan as part of its review process.
- D. The Lancaster County Planning Commission ranked the CIP project request and voted unanimously to revise the previously adopted CIP to include the CIP project requests.
- E. The Lancaster County Planning Commission recommends the CIP as amended to the Lancaster County Council for approval.

### **Section 2. Adoption of Document; No Funding Authorized.**

The Lancaster County Council hereby adopts the Revised Lancaster County Capital Improvement Plan 2022 – 2031 document as more specifically detailed in the attached Exhibits. Inasmuch as this is strictly a financial planning document, no funding for any project contained therein is authorized through the adoption of this ordinance.

**Section 3. Severability.**

If any section, subsection or clause of this ordinance is held to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections and clauses shall not be affected.

**Section 4. Conflicting Provisions.**

To the extent this ordinance contains provisions that conflict with provisions contained in the Lancaster County Code or other County ordinances, the provisions contained in this ordinance supersede all other provisions and this ordinance is controlling.

**Section 5. Effective Date.**

This ordinance is effective upon Third Reading.
