#### **MINUTES**

Committee Members present at the Infrastructure and Regulation (I & R) Committee regular meeting were Larry Honeycutt, Terry Graham and Billy Mosteller. Also present at the meeting were County Administrator Steve Willis, Deputy County Administrator Alison Alexander, County Attorney John DuBose, Clerk to Council Sherrie Simpson, Sheriff Barry Faile, Airport Director Paul Moses, Ken Holt with Holt Consulting Company, Zoning Enforcement Officer Jeff Mullis, Recreation Director Hal Hiott, Public Works Director Jeff Catoe, various staff and citizens. A quorum of the Lancaster County I & R Committee was present for the meeting.

The following press were notified of the meeting by e-mail in accordance with the Freedom of Information Act: Lancaster News, Kershaw News Era, The Rock Hill Herald, Cable News 2, Channel 9 and the local Government Channel. The agenda was posted in the lobby of the County Administration Building and also on the county website for the required length of time.

## Call to Order - Committee Chair Larry Honeycutt

Larry Honeycutt called the regular monthly meeting of the Infrastructure and Regulation (I & R) Committee to order at approximately 3:03 p.m.

#### **Approval of the Agenda**

Billy Mosteller moved to approve the agenda as written. The motion was seconded by Terry Graham. The Committee approved the agenda as written by unanimous vote of 3-0.

## **Citizens Comments**

Gil Small, Lancaster, SC, spoke regarding walking in the gym at the Buford Recreation Department.

## **Approval of Minutes**

Terry Graham moved to approve the minutes from the September 10, 2019 I & R Committee regular meeting. The motion was seconded by Billy Mosteller. The Committee approved the minutes from the September 10, 2019 I & R Committee regular meeting by unanimous vote of 3-0.

## **Discussion/Action Items**

a. Update the Capital Improvement Plan for Airport - Ken Holt/Paul Moses/Ed Lee

Larry Honeycutt commended Jeff Catoe, Director of Public Works, for having the Public Works Department clean up Aviation Boulevard. Paul Moses introduced Ed Lee, Chair of the Airport Commission, who was in attendance at the Committee meeting.

Ken Holt, with Holt Consulting Company, LLC explained that the Federal Aviation Administration (FAA) requests that airports update their five year Capital Improvement Plans (CIP) each year. He reviewed the Lancaster County Airport (LKR) Capital Improvement Plan (CIP) FFY 2021 - FFY 2025 that was attached in the agenda packet. He explained that the plans for 2020 and 2021 should not need to change but that the proposed plans for 2022 and beyond can change. He further explained that the CIP does not obligate the County to spend any money.

Billy Mosteller moved to adopt the CIP, to move forward with seeking a grant and to move the plan forward to full Council with a favorable recommendation from the I & R Committee. The motion was seconded by Terry Graham. The motion passed by unanimous vote of 3-0.

## b. Discussion of Yard Signs in the County - Larry Honeycutt

Larry Honeycutt explained that he considered the yard signs, put up by businesses on the weekends, litter. He asked for suggestions on how to deal with the yard signs. Steve Willis explained that many of the companies are not South Carolina companies and that the offense would be a magistrate's court offense. He further explained that the County does not have enough staff to work on the issue. Alison Alexander explained that the County has one Code Enforcement Officer and that he does not work on the weekends. She noted that the County has been addressing the issue by complaints. Larry Honeycutt noted that this item was for discussion only.

#### c. Discussion regarding Animal Control Enforcement for Barking Dogs - Larry Honeycutt

Larry Honeycutt asked what can be done about barking dogs in a neighborhood. He noted that barking dogs are a form of nuisance and that dogs have been snapping at people's heels while they are walking. Sheriff Barry Faile explained that when the Sheriff's Office receives a complaint, they send Animal Control out to the house and find out who owns the dog and advise them to possibly get a bark collar to control the barking. He explained that charges can be brought against people but that, with the understanding, that the complainants will have to testify in Court. He noted that citizens will normally work with the Sheriff's Department regarding complaints.

## **Adjournment**

Terry Graham moved to adjourn the I & R Committee regular meeting. The motion was seconded by Billy Mosteller. The motion to adjourn passed by unanimous vote of 3-0. There being no further business, the I & R Committee meeting adjourned at approximately 3:46 p.m.

#### **Issue for Consideration:**

The County Code currently calls for the Airport Commission to operate the County Airport. Section 3-23 outlines the duties of the Airport Commission, which include budgeting, recommending methods of management and operation, appointing an operator, developing plans for maintenance and future use, and accepting grants and other items to benefit the airport.

This section has been revised and updated over the years but flows from Ordinance 68 adopted on June 24, 1981.

#### **Points to Consider:**

This is one method of operating the airport but not the only method. State Statute 55-9-190(1) allows a county to operate the airport or vest that authority in a board.

I did check with Mr. James Stephens, Director of the SC Aeronautics Commission, and there are no FAA or SC Aeronautic regulations on this topic.

How the Council decides to operate the Airport is entirely up to County Council. Council may (1) operate it solely as a County Department; or (2) operate it as a County Department with an Advisory Board; or (3) have it remain under the control of the Lancaster County Airport Commission.

ARTICLE I. - IN GENERAL

ARTICLE II. - AIRPORT COMMISSION

Sec. 3-21. - Purpose.

The purpose of the Lancaster County Airport Commission shall be to administer the handling of all matters affecting airports and to establish rules, policies, plans and procedures for the Lancaster County Airport.

## Sec. 3-22. - Composition and meetings.

- (a) The commission shall be composed of seven (7) members appointed by the county council. Each council member shall recommend one (1) member to represent the council member's district; however, residency in the council member's district is not required.
- (b) (1) The term of office for airport commission members is four (4) years. All terms end on June 30. A person who has served two (2) consecutive terms on the airport commission is ineligible for appointment for an additional term unless a period of at least two (2) years has elapsed since the expiration of the person's last term; provided, however, upon a two-thirds (2/3) vote of the county council members, a person may be reappointed to the commission notwithstanding the term limitation. Time served in filling a vacancy is not included in the term limitation. Members serve until their successors are appointed and qualified. Vacancies must be filled for the unexpired term in the same manner as the original appointment.
  - (2) A member of the commission who misses three (3) consecutive meetings of the commission during any fiscal year or a total of five meetings in any fiscal year vacates the office to which the member is appointed. The vacancy in the office exists as of the end of the meeting missed by the member that triggers the vacancy and the vacancy shall be filled in the same manner as other vacancies. When a vacancy occurs pursuant to this item, the commission chair or the chief administrative officer of the commission shall notify the clerk to council in writing as soon as possible.
  - (3) Members of the airport commission serve at the pleasure of county council.
- (c) The commission shall meet quarterly and at other times at the call of the chair. Each year, the commission shall elect a chair, vice-chair and secretary.
- (d) All members serve without compensation, but may be reimbursed for actual expenses and mileage pursuant to county policy after approval by the commission chair and the county administrator.

(e) Within one (1) year of the member's appointment and at such other times as may be required by county council, the member shall attend a training session provided by the county on the topics of fiduciary duties, county fiscal and personnel policies, and other responsibilities and duties of a commission member.

#### Sec. 3-23. - Duties.

#### The commission shall:

- (1) Prepare annual expense and revenue budgets for the operation of the Lancaster County Airport and the functions of the commission.
- (2) Recommend methods of management and operation of the county airport.
- (3) Appoint an operator for the county airport, subject to approval by the county council.
- (4) Develop plans for the maintenance and future uses of the county airport.
- (5) Accept for and in behalf of the county, by deed, gift, or otherwise from the federal government or any of its agencies, any and all property of every kind or description, the ownership of which by the commission may tend to promote and advance aeronautics in the county, provided that any property be titled to Lancaster County.

#### Sec. 3-24. - Financial controls; audit.

- (a) Annually, at the time designated by the county council, the commission shall submit to the county council an operating budget for the ensuing fiscal year adequate to fund the operation and programs of the commission.
- (b) The expenditure of any funds by the commission is subject to the purchasing rules and financial procedures of the county as adopted by the county council. The commission shall designate a person on the commission as liaison with the offices of the county administrator and county finance director to ensure compliance with these rules and procedures.
- (c) The county shall include the commission in the annual independent audit of the financial records of the county.
- (d) The commission is subject to the county's personnel policies including wage and salary guidelines.

#### Sec. 3-25. - Records and reports.

- (a) The commission shall maintain records of its meetings and shall forward copies of the minutes of each meeting to the county council within thirty (30) days of each meeting. The minutes shall reflect the date of the meeting, the members present and the business considered and decided. The secretary of the commission will transcribe the minutes of each meeting and forward them to the office of the county administrator for typing and distribution.
- (b) The commission shall report annually to the council or, upon request, concerning its activities. Council shall designate the time for the annual report.

## Sec. 3-26. - Freedom of information.

The Lancaster County Airport Commission is a public body within the meaning of Section 30-4-10 et seq. of the Code of Laws of South Carolina of 1976, as amended, also known as the Freedom of Information Act and, as such, is required to give public notice of its meetings and agendas and attempt to notify the press thereof as required by the Act.

In the event the commission requires the advice of legal counsel, the commission shall first contact the county attorney. If for any reason the county attorney is unable to represent the commission, the county attorney shall so advise the commission and the council. The council, upon recommendation of the commission, may provide substitute counsel if deemed necessary by council.

Sec. 3-28. - Inventory.

The commission shall keep an inventory of all equipment, furnishings, and facilities owned, operated, leased or used by the commission. The inventory shall clearly identify each item. The commission shall clearly mark for identification all county-owned equipment. The commission shall furnish a copy of the inventory to county council.

## CHAPTER 9 South Carolina Airports Act

SECTION 55-9-190. Powers as to airports and landing fields.

The division, counties, municipalities, and other political subdivisions of this State which have established airports which acquire, lease or set apart real property for these purposes may:

- (1) construct, equip, improve, maintain and operate airports or vest authority for the construction, equipment, improvement, maintenance and operation of it in an officer, board or body of the political subdivision, the expense of the construction, equipment, improvement, maintenance and operation to be a responsibility of such political subdivision;
- (2) adopt regulations and establish charges, fees and tolls for the use of such airports fix penalties for the violation of such regulations and establish liens to enforce payment of such charges, fees and tolls; and
- (3) lease these airports to private parties for operation or lease to private parties for operation space, area, improvements and equipment on such airports provided in each case that in so doing the public is not deprived of its rightful, equal, and uniform use of it.
