A quorum of Lancaster County Council was present for the meeting. ### **2nd Reading of Ordinance 2022-1832 regarding Approval of a Development Agreement for Shiloh Woods (Applicant Century Communities)**

Ordinance Title: An Ordinance To Approve A Development Agreement With Century Communities Southeast, LLC, In Accordance With Unified Development Ordinance Section 9.2.18 For A Proposed 398-Unit Single-Family Cluster Subdivision Development Located On Approximately 169.86 Acres Of Land At 500 And 516 W. Shiloh Unity Road (TMS#s 0049-00-004.13, 0049-00-004.16, 0049-00-005.01 And 0049-00-005.02). - **Planning Department Case Number: DA-2022-0733.**

Chairman Steve Harper recused himself from the discussion and vote on 2nd reading of Ordinance 2022-1832. Vice Chair Brian Carnes took over the meeting at approximately 7:19 p.m. Steve Harper's Statement of Recusal is attached as Schedule D to the written minutes in the Clerk to Council's office.

Rox Burhans reviewed the County Power Point presentation which is attached to the written minutes in the Clerk to Council's office. Rox Burhans stated the developer submitted the revised Traffic Impact Analysis (TIA) on November 22 so Planning has not been able to review the revised TIA due to the holidays.

Charlene McGriff moved to approve the 2nd Reading of Ordinance 2022-1832. Seconded by Billy Mosteller.

Terry Graham stated the school fees and the fire fees were not high enough.

The motion to approve the 2nd Reading of Ordinance 2022-1832 Passed 5-1-1. Ayes: Blackmon, Carnes, Honeycutt, McGriff, Mosteller; Nayes: Graham; Abstain: Harper.

Steve Harper returned to the meeting at approximately 7:24 p.m. and resumed his duties as Chair of the meeting.

## **2nd Reading of Ordinance 2022-1836 Amending That Certain March 22, 2021 Special Source Revenue Credit Agreement By And Between Lancaster County And Studio Displays, Inc. To Add T&T Capital, LLC As A Party Thereto With Retroactive Effect**

Ordinance Title: An Ordinance To Authorize The Execution And Delivery Of An Amendment To That Certain March 22, 2021 Special Source Revenue Credit Agreement By And Between Lancaster County, South Carolina And Studio Displays, Inc. (The “SSRC Agreement”) To Add T&T Capital, LLC As A Party Thereto With Retroactive Effect; To Extend The Provision Of Special Source Revenue Credits Under The SSRC Agreement To Investment Made By T&T Capital, LLC In Lancaster County; And To Provide For Other Matters Related Thereto.

Brian Carnes moved to approve the 2nd Reading of Ordinance 2022-1836. Seconded by Larry Honeycutt.

John DuBose stated the ordinance would add T&T Capital, LLC to the capital agreement with Studio Displays Incorporated.

The motion to approve the 2nd Reading of Ordinance 2022-1836 by title only Passed 7-0. Ayes: Blackmon, Carnes, Graham, Harper, Honeycutt, McGriff, Mosteller; Nayes: None.

### **Discussion and Action Items**

#### **Approval of Re-Appointments to Various Boards or Commissions**

- James Barnett to the Planning Commission as the District 5 representative INSTEAD of the District 4 representative due to redistricting. If approved as the District 5 representative, he would fill an unexpired term that would end on 06/30/2025
- Phyllis Jarvis to the Library Board as the District 5 representative INSTEAD of the District 4 representative due to redistricting. If approved as the District 5 representative, she would fill an unexpired term that would end on 06/30/2025

Larry Honeycutt moved to approve the re-appointment of James Barnett to the Planning Commission and Phyllis Jarvis to the Library Board effective January 1, 2023. Seconded by Allen Blackmon. The Motion Passed 7-0.

#### **Approval of Appointment to the Health and Wellness Commission**

- Terri Lee as the District 3 representative to the Health and Wellness Commission to fill an unexpired term that ends on 06/30/2023 AND to serve a new four year term that begins on 7/1/2023 and ends on 06/30/2027.

Billy Mosteller moved to approve the appointment of Terri Lee to the Health and Wellness Commission. Seconded by Charlene McGriff. The Motion Passed 7-0.

#### **Adoption of the 2023 Calendar Meeting Schedule for Council, Committees, Boards and Commissions, and Advisory Boards and Adoption of the 2023 Holiday Schedule for the County**

Charlene McGriff moved to approve the adoption of the 2023 Calendar Meeting Schedule for Council, Committees, Boards and Commissions, and Advisory Boards and the adoption of the 2023 Holiday Schedule for the County. Seconded by Brian Carnes. The Motion Passed 7-0.

### **Discussion of Lot Limits on Dead End Roads**

Rox Burhans explained that staff was asked to provide an update to Council on the maximum number of lots that would be allowed on closed or dead end roads. He further explained that the current Unified Development Ordinance (UDO) allows a dead end road to be 800 linear feet with no more than 20 lots. He noted that the standard was adopted in 2016. He noted that many older roads were restricted by this regulation, such as Green

Pond Road. He noted that Council may want to consider a text amendment to address this issue. He explained that there were many issues that will be impacted by such a text amendment, such as the 5 lot limit for minor subdivisions, legacy roads, and the private drive 5 lot limit.

Council and staff discussed the history of the 2016 standard, Green Pond Road, or whether the issue needed to be addressed immediately or could wait until the full UDO rewrite. Council requested that staff move forward with a text amendment and send it to the Planning Commission for consideration.

## **Rock Hill Fort Mill Area Transportation Study (RFATS) Update for Highway 521**

Brian Carnes reviewed the County Power Point presentation regarding the Rock Hill Fort Mill Area Transportation Study (RFATS) update for Highway 521. He explained that the presentation would be high level because RFATS staff would be coming before Council at a later date to provide an in-depth presentation.
